Advising for Learning Support English and Reading Fall 2015

ENGLISH/WRITING

Students who meet any of the below benchmarks may enroll directly in ENGL 1010 <u>without</u> the corequisite ENGL 0815:

- An 18 or higher on the English portion of the ACT within the past 3 years
- A 77 or higher on the COMPASS Writing Skills exam within the past 3 years
- A 450 or higher on the Critical Reading portion of the SAT within the past 3 years
- Continuing NSCC students who've completed both modules of ENGL 0810 prior to fall 2015

To find the scores indicated above, log in to MyNSCC, and then:


- Select "My Self Service"
- Select the "Faculty Services" tab
- Select "Student Information Menu"
- Select the current term
- Select "View Test Scores"
- Enter student information (A Number)
- ACT, COMPASS, and learning support module information will be visible.
 - Students with a 4 for Developmental Studies Writing (DPSW) are at college level in English.
 - For students with a 1, 2 or 3 DPSW score, check to see if they have completed any LSE/ENGL 0810 modules prior to fall 2015. The modules are listed as Writing Adequacy (Module 1) and Writing Mastery (Module 2).
 - Students with a "Y" next to both modules may enroll in ENGL 1010 without a corequisite lab.
 - Students with an "N" next to one or both modules must enroll in ENGL 1010 and ENGL 0815.

Students with the scores below must enroll in ENGL 1010 and ENGL 0815:

- A 17 or lower on the English portion of the ACT within the past 3 years
- A 76 or lower on the COMPASS Writing Skills exam within the past 3 years
- A 440 or lower on the Critical Reading portion of the SAT within the past 3 years
- Continuing NSCC students who've completed one or zero modules of ENGL 0810

These students may not enroll in an online section of ENGL 1010.

Programs that do not require English/writing at the college-level:

Certain programs at NSCC do not require that students take college-level English/writing but do require that students achieve learning support competency in English. Students who have declared the following majors may enroll in ENGL 0810, which is a stand-alone class to deliver learning support competencies in English/writing to students who do not require college-level English:

READING

Students who meet any of the below benchmarks may enroll directly in a college-level class that has reading competency as a prerequisite. In the 2015-2016 catalog, these students will be designated as having Level 2 Placement in Reading.

- An 19 or higher on the Reading portion of the ACT within the past 3 years
- An 83 or higher on the COMPASS Reading exam within the past 3 years
- A 460 or higher on the Critical Reading portion of the SAT within the past 3 years
- Continuing NSCC students who've completed both modules of READ 0810 prior to fall 2015

To find the scores indicated above, log in to MyNSCC, and then:

- Select "My Self Service"
- Select the "Faculty Services" tab
- Select "Student Information Menu"
- Select the current term
- Select "View Test Scores"
- Enter student information (A Number)
- ACT, COMPASS, and learning support module information will be visible.
 - Students with a 4 for Developmental Studies Reading (DPSR) are at college level in English.
 - For students with a 1, 2 or 3 DPSR score, check to see if they have completed any LSR/READ 0810 modules prior to fall 2015. The modules are listed as Reading Adequacy (Module 1) and Reading Mastery (Module 2).
 - Students with a "Y" next to both modules may enroll in a college-level course with a Level 2 Placement in Reading as a prerequisite.
 - Students with an "N" next to one or both modules must enroll in READ 0815 + a designated college-level course (see list below)

Students with the scores below must enroll in READ 0815 and a designated college-level course:


- An 18 or lower on the Reading portion of the ACT within the past 3 years
- An 82 or lower on the COMPASS Reading exam within the past 3 years
- A 450 or lower on the Critical Reading portion of the SAT within the past 3 years
- Continuing NSCC students who've completed one or zero modules of READ 0810

College-level courses that can be taken with READ 0815 as a co-requisite:
