Course Description:

An introductory course in Digital Animation. Topics include the concepts, theory and aesthetics of digital design and animation; creating 2-D elements and 3-D models; applying surface materials, lighting, animating and rendering scenes. Additional topics include techniques used in product design and marketing, video games, and graphics for Web, film and broadcast video. Two lab hours may be taken as independent study.

4. Open and edit previously created 3D Projects.
5. Have a thorough understanding of all the aspects and techniques of 3D Design projects.

Course Competencies:

1. A basic level of computer literacy of the Windows environment is expected. The student should know how to open files, save files and follow a path to a file either on a hard disk or on a removable storage device.

Topics to Be Covered:

1. Mastery of Interface and command usage
2. Mastery and practice of 3D Concepts
3. Intermediate & Advanced techniques on how to use the commands most effectively Including Modeling, Materials & Textures, Lights, and Animation
4. Obtain a working knowledge of 3D Animation software

Course Assessments:

The following performance assessments will be used to demonstrate students' understanding, knowledge, and skills:

1. Students will be assessed on their ability to perform "hands on" creation of design exercises evaluated on accuracy, clarity, and techniques learned in this program.
2. Students will be assessed on their retention of learned materials through written or "hands on" designs for testing.

Grading Policy:

If you cannot take a test when scheduled, you must notify the instructor and make arrangements to take the test prior to the scheduled date. Homework not turned in on time is subject to a 25% grade reduction. Homework will not be accepted if more than one week late or after an assignment has been returned to the class, whichever comes sooner. Homework should reflect your understanding of the subject, not that of your classmates. There will be no makeup on missed labs. Make every effort to attend every lab.

Attendance Policy

According to NSCC policy, an FA is awarded to students who do not officially withdraw from a course and do not attend after the cut-off date provided in the academic calendar. “Last Day to Earn F for Attendance (FA).” Students who stop attending on or before this date receive an FA; students who stop attending after this date receive an F.

For online courses, attendance is defined by submission of assignments. Students who fail a course and whose last assignment is submitted on or before the FA date will earn an FA for the course. Students who fail a course and whose last assignment is submitted after the FA date will earn an F for the course. An FN is assigned to students who do not submit any assignments.

Inclement Weather & Campus Closings

Nashville State will use the RAVE alert system to send a text message to students, staff, and faculty about adjusted hours of operation and/or closings at individual campuses. Campus closures will also be announced on local television stations. Students should use their own best judgment in determining whether to report to campus during inclement weather when classes are not cancelled.

Even when campuses are closed, students are still responsible for completing all assigned work. When classes are cancelled, faculty will post online assignments and any additional instructions in the D2L/NS Online course shell. Check D2L/NS Online for a message from your instructor regarding your online assignment requirements. Faculty have discretion over adjusting deadlines or due date for assignments, but students are responsible for completing all assigned work by the due date established by the instructor.

Class Cancellation Policy
