#### **Course Description:**

An introduction to electric circuit quantities and components, systematic application of Ohm's and Kirchhoff's laws, superposition, Thévenin and Norton theorems, operational amplifiers, RL and RC transients, and computer circuit simulation.

Prerequisite(s): MATH 1920 and MATH 2010 . MATH 2010 may be taken concurrently.

#### **Course Outcomes:**

Upon successful completion of this course, students should be able to:

- 1. Know the differential and integral relationships involving the fundamental relationships of charge, current, voltage, power and energy.
- 2. Know the I-V relationships of resistors, sources, capacitors, and inductors.
- 3. Compute, by hand, the derivative or integral of a piecewise signal.
- 4. Set up and solve node and mesh equations for circuits containing resistors, independent sources, dependent sources, and operational amplifiers.
- 5. Draw and simulate circuits using Schematic Capture.
- 6. Use Multi-Sim to assist in analysis and plotting of circuit behavior.
- 7. Find the Thevenin and Norton equivalent of resistive circuits.
- 8. Understand linearity through the use of superposition.
- 9. Analyze and design simple circuits with op amps.
- 10. Solve for the complete response of RL and RC circuits with DC and nonconstant inputs.
