- Identify and demonstrate the proper use of lubricants, sealants and cleaners

- Instrumentation Safety Practices
- Instrumentation Hand and Power Tools
- Craft Related Math
- Electrical Systems for Instrumentation
- Construction components of Instrumentation
- Temperature, Pressure, Level and Flow
- Instrument Fitters Math

#### **Course Assessments:**

The following performance assessments will be used to demonstrate students' understanding, knowledge, and skills:

A student's mastery of the learning outcomes will be assessed through both module exam and performance evaluation as determined by The National Center for Construction Education and Research (NCCER). The student must pass each module assessment with a score of 70% in order to take the performance evaluation. Performance evaluations (PV) are graded as Pass/Fail and must be successfully completed in order to obtain grading credit for the module PV.

This is an NCCER class. Tests will be graded as follows:

- 1) All module exams must be passed with a 70% or higher to become "knowledge verified" through NCCER.
- 2) Any exams not passed at this level can and should be retaken. One re-take is allowed.\*
- 3) Although the student may make above a 70 on the re-take and become knowledge verified with NCCER, the grade of record for the NSCC grade will be the grade made on the first attempt. (See example below)
- 4) A score of 70 or above (initially or re-take) is required in order to allow the Performance Verification score.
- 5) Students with an unexcused absence on the day of a module exam will receive a zero (0) on the module exam for NSCC class scoring; however, the student will be able to retake the exam for NCCER "knowledge verification" purposes.
- 6) Students who know they will be absent in advance, and inform their instructor, will be given opportunity to test early without penalty.

Class notes, handouts, practice exercises and your textbook are excellent resources to prep for module exams. Written assignments will periodically be assigned for you do outside of class. Along with the required reading, the homework will guide you and require summarizing key points, conducting research or answering questions.

\*Example: A student scores a 56 on his first module exam attempt. Student re-takes the exam and scores a 72. The 72 now applies to the NCCER as being knowledge verified; however, the original score of 56 is the grade that applies for the NSCC class.

# Late Work Policy & Make-up Procedures for Missed Assignments and Work:

#### **Attendance Policy**

The College is not an attendance taking institution as defined by 34 CFR 668.22(b)(1) in the Code of Federal Regulations; however, students are expected to attend all scheduled classes and laboratories.

- Absences in a course may affect a student's final grade.
- Tardiness may also affect a student's final grade.
- Students are responsible for all work/tests that occur during any missed class session(s) regardless of reason(s) for absence.
- Students who are sick or not well enough to attend class must notify the instructor as soon as possible before the scheduled class time, unless incapacitated or unable to do so. In that case, students must contact the instructor as soon as reasonably possible.
- If a student has an unavoidable conflict with a scheduled class session, students must notify the instructor, preferably before the class session, or as soon as possible.

For purposes of financial aid continued attendance is determined via engagement in the course. This can be accomplished in several ways including, but not limited to, continued attendance and/or participation in on-ground class sessions, participating in D2L as prompted (e.g., responding to an instructor's email, posting to a discussion board), and/or completing and submitting assignments.)

To the extent that attendance is kept in this class it is not for the purpose of the College but is instead associated with the instructor's individual grading rubric. The attendance policy for this class is: Students are expected to attend all scheduled classes and laboratories. Absences in a course may affect a student's final grade. The student is responsible for all assigned work in the course regardless of excused or unexcused absences. Tardiness may also affect a student's final grade.

Attendance will be included as part of the student's grade. The student will be awarded an attendance grade of 100 for perfect attendance. Each absence, both excused and unexcused, will result in an attendance grade reduction of 5 points for a maximum of 5 absences. (i.e. 5 absences results in an attendance grade of 75%) A student with 6 or more absences will be awarded an attendance grade of 0.

Excused Absences allow the student to make-up any assignments or tests without penalty.

#### FA
