Course Description:

This course is designed for students in the maintenance technology program to be exposed to basic industrial electrical concepts. Topics include industrial safety for electrical and instrumentation, introduction to the NEC, electrical theory, alternating current, test equipment, flow, level, pressure and temperature, hand bending, tubing, instrument drawings and conductors and cables terminations and splices. Prerequisite(s): Level 2 placement or higher in Math or concurrent enrollment in MATH 0845

Course Assessments:

The following performance assessments will be used to demonstrate students' understanding, knowledge, and skills:

A student's mastery of the learning outcomes will be assessed through both module exam and performance evaluation as determined by The National Center for Construction Education and Research (NCCER). The student must pass each module assessment with a score of 70% in order to take the performance evaluation and advance to the next module of instruction. Performance evaluations are graded as Pass/Fail and must be successfully completed in order to advance to the next module of instruction.

Grading Policy:

This is an NCCER class. Tests will be graded as follows:

- 1) All module exams must be passed with a 70% or higher to become “knowledge verified” through NCCER
- 2) Any exams not passed at this level must be retaken in the testing center at a cost of \$3.00.
- 3) Although the student may make above a 70 on the re-take and become knowledge verified with NCCER, the grade of record for the NSCC grade will be the grade made on the first attempt
- 4) Students with an unexcused absence on the day of a module exam will receive a zero (0) on the module exam for NSCC class scoring; however, the student will be able to retake the exam for NCCER “knowledge verification” purposes.

Example:

John Smith makes a 56 on his first module exam attempt. John re-takes the exam and makes a 72. With the 72, John is now knowledge verified with NCCER; however, his grade for the NSCC class is his original 56.

Late Work Policy & Make-up Procedures for Missed Assignments and Work:

Attendance Policy

The College is not an attendance taking institution as defined by 34 CFR 668.22(b)(1) in the Code of Federal Regulations; however, students are expected to attend all scheduled classes and laboratories.

- Absences in a course may affect a student’s final grade.
- Tardiness may also affect a student’s final grade.
- Students are responsible for all work/tests that occur during any missed class session(s) regardless of reason(s) for absence.
- Students who are sick or not well enough to attend class must notify the instructor as soon as possible before the scheduled class time, unless incapacitated or unable to do so. In that case, students must contact the instructor as soon as reasonably possible.

- If a student has an unavoidable conflict with a scheduled class session, students must notify the instructor, preferably before the class session, or as soon as possible.

For purposes of financial aid continued attendance is determined via engagement in the course. This can be accomplished in several ways including, but not limited to, continued attendance and/or participation in on-ground class sessions, participating in D2L as prompted (e.g., responding to an instructor's email, posting to a discussion board), and/or completing and submitting assignments.)

To the extent that attendance is kept in this class it is not for the purpose of the College but is instead associated with the instructor's individual grading rubric. The attendance policy for this class is:

The student is expected to attend all scheduled classes and laboratories. Attendance will be 10% of the student's overall grade. Any absence, whether excused or unexcused, will result in an overall grade reduction of 0.5% up to 5 absences. Six or more absences will result in a grade of 0 for attendance. Absences are counted from the first scheduled meeting of the class. If a student is absent from a class, he/she should give an advanced explanation to the instructor. The student is responsible for all assigned work in the course regardless of excused or unexcused absences.

Excused Absence: The student will be given the opportunity to make-up any missed assignment.

Excused absences include sickness with a doctor's note, a death in the immediate family or as approved by the instructor.

Unexcused Absence: The student will be given a grade of "0" for any missed assignment. Unexcused Absences include all absences not approved by the instructor.

If the student is late for class by more than 30 minutes or leaves more than 30 minutes before being released by the instructor, the student will be counted as absent for the class.

According to NSCC policy, an FA is awarded to students who do not officially withdraw from a course and do not attend after the cut-off date provided in the academic calendar.
