Course Title: MECH 1200 Mechanical Components

Credits: 4

Class Hours: 3 class hours, 2 lab hours

Course Description:

This course is a study of the basic mechanical components and electrical drive in a mechatronics system. Topics covered will include basic functions and physical properties of mechanical components and electrical AC and DC drives; materials, lubrication requirements and surface properties; troubleshooting techniques and strategies to identify, localize and correct malfunctions; and systematic preventative maintenance and electrical component safety. Technical documentation such as data sheets and specifications of mechanical elements and electrical drives will also be covered. Students will calculate component sizes for clearance and force fits of mechanical assemblies.

11. Correctly apply mechanical material analysis for shafts, couplings, and sealing devices with proper

13. Describe and analyze power transmission components such as clutches and brakes and how they
14. are used.
15. Carry out adjustments on mechanical components in a mechatronic system.
16. Read, analyze and utilize the technical data sheets for the mechanical components and electrical
17. drives within a mechatronic system.
18. Calculate component part sizes for in clearance and force fits
19. Identify and select proper lubricants for mechanical system applications

Course Competencies:

- Explain the role of various mechanical components within a given system or module
- Trace and describe the flow of energy in a given mechatronic system or subsystem.
- Describe the basic physical properties of mechanical components including materials, lubrication requirements and surface properties.
- Carry out adjustments on mechanical components in a mechatronic system.

- Read, analyze and utilize the technical data sheets for the mechanical components and electrical drives within a mechatronic system.
- Correctly localize, identify and document causes of malfunctions in mechanical components or electrical drives, based upon the technical documentation.
- Correct malfunctions where possible, or correctly identify the expertise required to correct a malfunction.
- Apply safety rules while working on the system.
- Transfer the knowledge learned from one system to another system.
