Assignments:

- Journal Article Review: The purpose of this assignment is to encourage the student to become familiar with references frequently used in occupational therapy literature through exploration of current research. In this assignment, the student will choose an article of interest and summarize following assignment guidelines. Students will be expected to provide a critique of the structure (readability) of the article and the rationale for their selection. Through this assignment the student will begin learn the importance of using evidence in daily practice. Further information and assignment details are provided in the Learning Module.
- Frame of Reference Paper: This assignment requires students to carefully review several different Frames of Reference and Models of Practice commonly used in Occupational Therapy. Students will apply their knowledge of each to a case scenario, outlining how OT intervention could change dependent upon the approach used. Further information on this assignment may be found in the Learning Module.
- Weekly Learning Activities: Weekly Learning Activities reinforce concepts addressed in assigned chapter readings. Students are required to interact and share ideas with each other through discussion questions, complete application based questions for provided scenarios, and reflect on new concepts and ideas through direct discussion with course instructor.
