**Course Title: OTAP 1320 Exploring Occupations**

#### **Course Description:**

This course provides in-depth study of occupations and begins to introduce students to how therapeutic occupations are used in OT practice. Topics include occupational and activity analysis, grading, exploration of therapeutic media, selection, adaptation and sequencing of purposeful/meaningful activities.

#### **Task Analysis Competency:**

This three-part assignment requires students to analyze routine tasks from the seven different Areas of Occupation, as identified in the OT Practice Framework. Tasks will be analyzed according to Performance Skills, Performance Patterns, Context, Activity Demands and Client Factors. Students will also identify how a particular activity can be graded for complexity or simplicity, and adapted according to need. Further information and assignment details are provided on D2L.

**Teaching Competency:** Students will identify an activity of choice and teach the activity to a partner. Standard teaching method to be followed. Further assignment details and grading criteria available on D2L.

**Activity Grading Competency:** Students will identify an activity of choice (different from Teaching Competency) and demonstrate how the activity can be graded up for complexity or graded down for

simplicity. Student will be required to teach the activity to a partner. Further assignment details and grading criteria available on D2L.

**Activity Adaptation Competency:** Students will identify two activities of choice (different from Teaching and Grading Competency) and demonstrate how the activity can be adapted for compromised Motor, Process and Communication Performance skills. Student will be demonstrating adaptations to instructor. Further assignment details and grading criteria available on D2L.
