- Apply correct techniques while keying.
- Demonstrate improved speed and accuracy while keying.

- Correctly apply spacing rules for symbols and punctuation keys.
- Correctly apply language arts rules in comma usage, sentence structure, and using quotation marks and italics,
- Identify and correct errors in spelling, capitalization, using apostrophes, and expressing numbers.
- Demonstrate acceptable proofreading skills.
- Identify and apply basic proofreaders' marks.
- Correctly format business correspondence such as letters, memos, and reports.
- Discuss various topics related to keyboarding skills and equipment.

# **Grading Policy:**

# **Keyboard Lesson Assignments**

Lesson assignments consist of completing each assigned keyboarding lesson in the module at the <u>Gregg College Keyboarding Website</u> by the cutoff date and submitting the assignment in the assignment dropbox. Automatic feedback is provided by the keyboarding software so that students can determine if they are meeting the lesson goals. If a student is not meeting a lesson goal, he or she should repeat the lesson again.

**Lessons 1-10** and **Lessons 11-20** will be graded. All sections in each lesson must be completed. Each keyboard lesson assignment is worth **20 points**. **Two points will be deducted for each missing or incomplete lesson**.

Keyboard lesson assignments have **due dates** and **cutoff dates**. In order to allow a grace period for late submissions, the cutoff date for lesson assignments will be **two days** after the **due date**. **Keyboard lesson assignments will not be accepted after the cutoff date**.

### **Timed Writings**

Students will complete several timed writings throughout the term at the <u>Gregg College Keyboarding Website</u>. After the student completes a timed writing, the keyboarding software will automatically calculate the speed (words per minute) and number of errors. Selected timings will be chosen for grading. Students will submit timed writings in the assignment dropbox.

The graded timed writings will be **three minutes** in length with an error limit of **three errors**. If the timing has more than three errors, a grade of **zero** will be recorded. Each timed writing is worth **50 points**.

Timed writings are to be completed and submitted by the due date listed on the current term schedule. Timed writings have **due dates** and **cutoff dates**. In order to allow a grace period for late submissions, the cutoff date for timed writings will be **two days** after the **due date**. **Timed writings will not be available or accepted after the cutoff date**.

#### **Word Processing Documents**

Students will use Microsoft Word to complete assigned word processing documents. Each graded word processing document is worth **20 points**. Students will submit documents in the assignment dropbox. Grading rubrics will be used to evaluate word processing document assignments and will be posted in the assignment dropbox.

Word processing documents are to be completed and submitted by the due date listed on the current term schedule. Word processing assignments have **due dates** and **cutoff dates**. In order to allow a grace period for late submissions, the cutoff date for word processing documents will

be two days after the due date. Word processing assignments will not be accepted after the cutoff date.

#### Discussions

The discussion area is provided as a place for students to introduce themselves, interact with their classmates about topics relating to classwork, as well as for the instructor to post important class announcements. Therefore, students should check the discussion board frequently.

Assigned discussion questions will also be posted on the discussion board by your instructor. Participation in the discussion is required and will be counted as part of the final grade. **The discussion assignments are worth 30 points each**.

Do your very best to use proper grammar and punctuation when posting your discussions! Please refer to the schedule for due dates for discussion assignments. Discussions have **due dates** and **cutoff dates**. In order to allow a grace period for late submissions, the cutoff date for the discussion will be **two days** after the **due date**. **Discussions will not be available or accepted after the cutoff date**.

Discussion assignments will be graded based on the completeness and accuracy of the student's post as well as a reply to another student's post. Discussion grading rubrics will be used to evaluate discussions. The rubrics will be posted in the discussion assignments.

Please review the <u>netiquette rules</u> carefully. You are expected to abide by them when posting on the discussion board or sending e-mail messages in this course.

### Quizzes

Students will complete quizzes in NS Online throughout the term. **Quizzes are worth 20 points each.** Students have three attempts on the quizzes. Quizzes will be scored automatically after they are submitted, and grades should be posted immediately. Please refer to the schedule for the due date for completion of guizzes.

Quizzes have **due dates** and **cutoff dates**. In order to allow a grace period for late submissions, the cutoff date for quizzes will be **two days** after the **due date**. **Quizzes will not be available or accepted after the cutoff date**.

#### **Tests**

Two tests (a midterm and a final exam) will be given during the term. Tests will be completed in NS Online. Each test is worth 200 points. Tests must be completed by the **due date** listed on the current term schedule. If a test is not completed, a grade of zero will be recorded.

#### FA

### **General Policy**

### **Instructor's Policy**
