- Demonstrate an understanding of business vocabulary terms.
- Discuss various topics related to business English.

Grading Policy:

Unit Quizzes

Quizzes will be given covering material in each unit. You will have three attempts on the quizzes, and the highest grade will be recorded. Quizzes will be scored automatically after they are submitted, and grades should be posted immediately. They are worth **40 points** each.

Spelling Review Quizzes

Quizzes will be given covering spelling words on frequently misspelled words lists provided in the text. Quizzes will be scored automatically after they are submitted, and grades should be posted immediately. They are worth **20 points** each.

Editing Assignments

Students will complete chapter assignments online in **MindTap**. **Practice exercises** and a **graded exercise (Real-world editing exercise)** are included for each chapter. Practice exercises allow students the opportunity to track their learning progress as the exercises provide automatic feedback. Some practice exercises within each chapter allow students multiple attempts to complete the exercises.

The graded chapter assignments (Real-world editing exercises in MindTap) are worth **30 points** each. Assignment grades will be posted within one week.

Discussions

Your instructor will post **assigned discussion questions** on the discussion board. Participation in these discussions is required and will be counted as part of the final grade. **Discussion assignments are worth 10 points** each. A discussion grading rubric will be used to evaluate discussions and will be posted in the discussion assignment. Discussion grades will be posted within one week.

Tests

Three unit tests and a final exam will be given. Each exam is worth 100 points. Tests must be completed by the DUE date. Test grades will be posted within one week.

FA

If you stop attending class or if you are in an online class and stop submitting assignments, but do not turn in a withdrawal form by the deadline, you are still enrolled in class. Late Work Policy & Make-up Procedures for Missed Assignments and Work:

Assignments, quizzes, and discussions have **due dates** and **cutoff dates**. In order to allow a grace period for late submissions, the **cutoff date** for assignments will be **two days after the due date**. Assignments, quizzes, and discussions will NOT be accepted after the cutoff date. Tests must be completed by the **DUE dates**.

Instructor’s Policy

The attendance policy for this course is the following: Attendance in this course is critical to success. A student is expected to attend all scheduled classes. Technology Statement
