- Use database functions.
- Create or select an Excel template.
- Create and modify PivotTables and PivotCharts.
- Create and modify SmartArt graphics.
- Import data into Excel and manage imported data.
- Inspect a workbook.
- Apply conditional formatting and manage conditional formatting rules.
- Discuss online resources on various topics related to spreadsheets.

**Grading Policy:**

**Grader Projects**

Grader projects will be assigned for each chapter through MyLabIT. Students will read the assigned chapter, complete the projects, submit the files for each chapter, and receive automatic feedback from MyLabIT. Grades are automatically recorded upon submission of the projects. The **four lowest grader projects** will be dropped at the end of the term.

**Quizzes**

Quizzes will be given covering material in each chapter and will be completed in NS Online. Quizzes will be scored automatically after they are submitted, and grades should be posted immediately. The **lowest quiz grade** will be dropped at the end of the term.

**Discussions**

Your instructor will post **assigned discussion questions** on the discussion board. Participation in these discussions is required and will be counted as part of the final grade. A discussion grading rubric will be used to evaluate discussions. Discussion grades will be posted within one week.

**Midterm Project**

The midterm project will help students develop their spreadsheet skills by creating and designing a worksheet of their own. Specific directions and the assessment criteria for the project are provided in an instructional handout in the Content area of the course. The project is worth 15 percent of the final grade.

**Exams**

Two exams will be given: a **midterm exam** and a **final exam**. Each exam is worth 15 percent of the final grade. Exams must be completed by the DUE date. Exam grades will be posted within one week.

## **FA**

If you stop attending class or if you are in an online class and stop submitting assignments, but do not turn in a withdrawal form by the deadline, you are still enrolled in class. You will be given a grade of FA, which means you have failed due to not attending class and not completing your assignments. ### **Late Work Policy & Make-up Procedures for Missed Assignments and Work:**

Chapter assignments, grader projects, quizzes, and discussions have **due dates** and **cutoff dates**. In order to allow a grace period for late submissions, the **cutoff date** for assignments will be **two days after the due date**. Chapter assignments, grader projects, quizzes, discussions, and the midterm project will NOT be accepted after the cutoff date.

The midterm exam and final exam must be completed by the **DUE dates**.
