Course Description:

A continuation of CHEM 2010. Topics include spectroscopy, alcohols, ethers, aldehydes, ketones, carboxylic acids, and amines. The lab component stresses skills in synthesis, extraction, purification, separation, and characterization of organic compounds.

Course Outcomes:

Upon successful completion of this course, students should be able to:

- 1. Describe an S_N1, E1, S_N2, and E2 reactions on the basis of substrate, solvent, nucleophile, and leaving group.
- 2. Predict the stability of conjugated systems and use the rules of resonance structures to explain thermodynamic and kinetic outcomes of appropriate reactions.
- 3. Identify aromatic, anti-aromatic, and non-aromatic compounds, including heteorcycles and devise synthetic pathways for aromatic compounds and write mechanisms for ordinary aromatic reactions.
- 4. Apply aliphatic reaction principles to aromatic side chain reactions and devise synthetic pathways of reactions involving α-substitution of a carbonyl group such as the malonic ester synthesis and acetoacetic ester synthesis.
- 5. Predict the major organic product of nucleophilic addition reactions to aldehydes and ketones, nucleophilic acyl substitution of carboxylic acid derivatives and of aldol, crossed aldol, and intramolecular aldol reactions.
- 6. Develop an expanded working knowledge of Infrared Spectroscopy, Mass Spectrometry, Nuclear Magnetic Resonance Spectroscopy, and their use in organic structure determination.
