- Install and configure Windows 2016 Server in a virtual machine
- Install and verify server roles including DHCP, DNS, and Hyper-V
- Install and verify Active Directory with Windows 2016 server functioning as a domain controller
- Join a Windows 10 workstation to a Windows 2016 server domain after creating domain user and computer accounts
- Install and configure virtual hard drives and virtual switches in a Windows 2016 server
- Create and apply an IPv4 and IPv6 addressing scheme to a Windows 2016 server network
- Install and manage printers in a Windows 2016 server
- Create group policy objects in a windows 2016 server

Topics to Be Covered:

- Installation and configuration of Windows 2016 Server
- Configuring local storage, print, and document services
- Controlling data access through NTFS and shared permissions
- Configuring servers for remote management
- Configuring Hyper-V with virtual networking and virtual storage
- Configuring DHCP, DNS and Domain Controller server roles
- Configuring and managing Active Directory services
- Creating and implementing group policies
