## **OTAP 2350 Intervention and Treatment of Pediatrics**

This syllabus sets forth the expectations for course content, work, and grading as well as expectations for student performance and conduct. ### **Course Information:**

Course Title: OTAP 2350 Intervention and Treatment of Pediatrics Credits: 3 Class Hours: see course schedule

### **Course Description:**

This course will address limitations and obstacles to occupational engagement (self-care, play, school) for persons from birth to age 22. Common diagnoses, evaluation methods, and treatment environments will be presented. Treatment for areas of occupation (ADL, IADL, education, work, play, leisure, rest/sleep, and social participation), considering performance skills, performance patterns, client factors and context will be reviewed. Students will be required to develop applications for enabling function and well-being. Pre- requisites: 1310: admission to OTA program, OTAP 1340, OTAP 1350, OTAP 1360, OTAP 1370, OTAP 1380 OTAP 1240 or permission by instructor
