**Course Title: Introduction to Theatre**

### **Course Description:**

An introduction to the basic social, artistic, and technical elements of theatre. Topics include theatre as storytelling; dramatic genres, styles, and structures; and the contributions of the playwright, designers, director, actors, and audience to the theatrical process.

**Prerequisite(s):** <u>Level 1 placement in English</u>; <u>Level 2 placement in Reading</u> or concurrent enrollment in READ 0815.
