**Course Title:** CHEM 1050 – Survey of Chemistry

**Course Description:**

An introduction to the fundamental concepts of General, Organic and Biological Chemistry. Topics include measurements, energy and matter, atoms and elements, compounds and their bonds, chemical reactions and quantities, gases, solutions, acids and bases, saturated and unsaturated hydrocarbons, organic compounds, carbohydrates, lipids, amino acids, proteins and enzymes, and metabolic and energy pathways.

### Course Assessments:

#### Homework

The students will be provided with different homework assignments, which are designed by the instructor. **These assignments must be turned in by or before the due date.**

#### Quizzes

Ten Quizzes (10 pts each) are given during the first twenty minutes of the class time and can consist of questions relating to the lecture material covered on each chapter.

#### Exams

Four tests (100 pts each) will be given during the semester along with a comprehensive final (100 pts). The date of each test will be given in class no later than one week before the test will take place.

#### Laboratory

Laboratory grades are assessed by the quality of laboratory worksheets (20 pts each). Note, laboratory participation affects your lab grade! Students are expected to follow the safety rules. Failure to do so will result in docking of points on lab worksheets. A short pre-lab lecture will precede the laboratory exercise. If you miss the pre-lab, you will NOT be allowed to perform the exercise and will earn a "0" for that lab. Lab worksheets are due at the end of laboratory sessions.

### Grading Policy:

### Attendance Policy

- Absences in a course may affect a student's final grade.

### FA
