**Course Description:** *This course covers various components, circuits, instruments, and control techniques used by industry in automated process control systems.* Topics include electrical and mechanical transducers applied in the measurement of temperature, pressure, flow and position, and exercises using computers and computer interfacing to give a realistic approach to the industrial application of these devices. Lab exercises are included to demonstrate course topics.

- Mathematically determine measurement results and errors using probability and statistics.
- Analyze measurement results and errors using probability and statistics
- Describe the principles of "meter loading" and sensitivity, dead band, calibration, and types of errors.
- Observe "meter loading" and sensitivity, dead band, calibration, and types of errors.
- Describe the use and theory of potentiometers and resistance bridges and their application.
- Observe the operation of potentiometers and resistance bridges and analyze the results
- Observe the operation of sensors and actuators
- Describe the principles of closed and open loop control
- Describe the operation of transducers and the use of transducers in industry
- Describe the operation of various MEMS
