Horticulture and Landscape Gardening Technical Certificate: The program was implemented in Fall 2001. The program requires one year to complete. Instructional methodologies include lecture, tean projects, oral presentations, field trips and extensive hands-on activities. Appendix F is labeled "Horticulture Faculty Roster and Vitae, Fulltime and Selected Adjunct Instructors." There is no roster; please submit a roster using the Commission form. We shall defer action until we receive the additional information requested.

Music Technology Technical Certificate: The program was implemented in January 1999, and requires one year to complete. All courses in the program are offered as traditional on-campus classes. We approve the proposal, shall include it within the scope of accreditation previously granted, and wish you and your colleagues continuing success with the program.

Early Childhood Education A.A.S. degree, certificate program, and Associate of Science in Teaching (A.S.T.) degree: The Early Childhood A.A.S. degree program began in 1999 the technical certificate was offered in 2003. The A.A.S. degree requires 60 credits to complete; the technical certificate requires 22 credits. The A.S.T. degree program will be implemented Fall 2007. Sixty-seven percent of the Early Childhood Education program courses are available via the web. Appendix F is labeled, "Early Childhood Faculty Roster and Vitae." There is no roster; please submit a roster using the Commission form. We shall defer action until we receive the additional information requested. Enclosed is an invoice for \$1200 to defray the costs associated with the review of these substantive changes.
